## Royal Canadian Mounted Police (RCMP)

### NCECC (National Child Exploitation Coordination Centre)

The Royal Canadian Mounted Police's National Child Exploitation Coordination Centre (RCMP NCECC) in Canada is a CPP [Global Reference Group](#) partner. RCMP NCECC provides investigational support and specialized services to national and international law enforcement in cases involving ICT enabled child sexual exploitation.

As one of the original Steering Committee (now known as the Global Reference Group) members, RCMP NCECC is the body that advises on the law enforcement direction for CPP and shares expertise such as its experience with [Microsoft's](#) Child Exploitation Tracking System (CETS) tool. RCMP NCECC also connects CPP to its various affiliates like the Virtual Global Task Force (VGT), and the RCMP liaison officers working with local law enforcement in countries where CPP is implemented to broaden the reach and impact of CPP.

The mandate of the NCECC is to reduce the vulnerability of children to Internet-facilitated sexual exploitation by identifying victimized children; investigating and assisting in the prosecution of sexual offenders; and, strengthening the capacity of municipal, territorial, provincial, federal, and international police agencies through training and investigative support.

In January 2003 the Toronto Police Service (TPS) contacted Microsoft Corporation and asked for help in dealing with the problem of online sexual exploitation of children. An assessment of the situation revealed that improvements in Canadian law enforcement's efforts in some of these areas needed to be made. A software package called CETS resulted from the TPS/Microsoft partnership. Microsoft Canada's contribution to this initiative is valued at approximately \$2.5 million.

### RCMP-TLO's –Child Protection System

CPS pools criminal data from a variety of other sources such as IRC, Ares, Open FastTrack, eDonkey and Gigatribe. CPS features include target identification by IP range, task-force commander tools, and cutting-edge analytics.

### Child Exploitation Tracking System (CETS)

CETS was developed by Microsoft Canada, RCMP and the Toronto Police Service following a personal e-mail plea from Toronto Police Detective Sergeant Paul Gillespie to Microsoft Chairman and Chief Software Architect Bill Gates in January 2003.

The new tracking system has already resulted in the November 2004 arrest of one alleged Toronto child pornographer. He was identified and targeted during beta testing of the computerized database and investigation system.

### RCMP Presentation at VGT (Virtual Global Taskforce)

It was a promising event when Mr. Chris Purchas conducted a stunning presentation at last VGT 2012 conference in Abu Dhabi about "Technology solutions and Collaboration used in child exploitation investigations". We, as a capacity of an NGO really felt a promising future toward Combating Child



Exploitation. Further to our research we also found RCMP has involved early in this noble endeavour by engaging Microsoft for developing tools like CETS.

We can't conclude our communication without a heartfelt appreciation to RCMP for their continuous struggle towards this effort.

## Court Experience & Testimony

In addition to preparing and handling criminal prosecutions through all levels of the court system, I have testified many times at both the Provincial and Superior Court levels, including testimony before sworn jury panels.

I have testified throughout the Greater Toronto Area, as well as the Northwest Territories.

## International Training

In March and November 2009 I participated as an instructor to 80 Cambodian police officers regarding Child Exploitation Investigations. I was one of three police officers from Canada who participated in this training. Forty officers from Phnom Penh and forty officers from Siem Reap received training in March and November 2009. Additionally five officers attended the Toronto Police Service Sex Crimes Conference in October 2009. Officer received instruction relating Child Sexual abuse, specifically in identifying victims, interviewing victims, and understanding police intervention. I specifically provided training on the use of computers by persons who have a



sexual interest in children. Officers were given training on how to preview images and videos on a computer, camera, memory card and other devices. Officers also received instruction on investigating sex tourists, and conducting searches for digital evidence. Additionally, I provided information regarding the number of persons suspected of peer to peer trading of child abuse images in Cambodia.

- e) Become a catalyst organization, which will work as an agency between technology and other social organizations by providing all the support of necessary safety and security measures of these technologies to these organizations

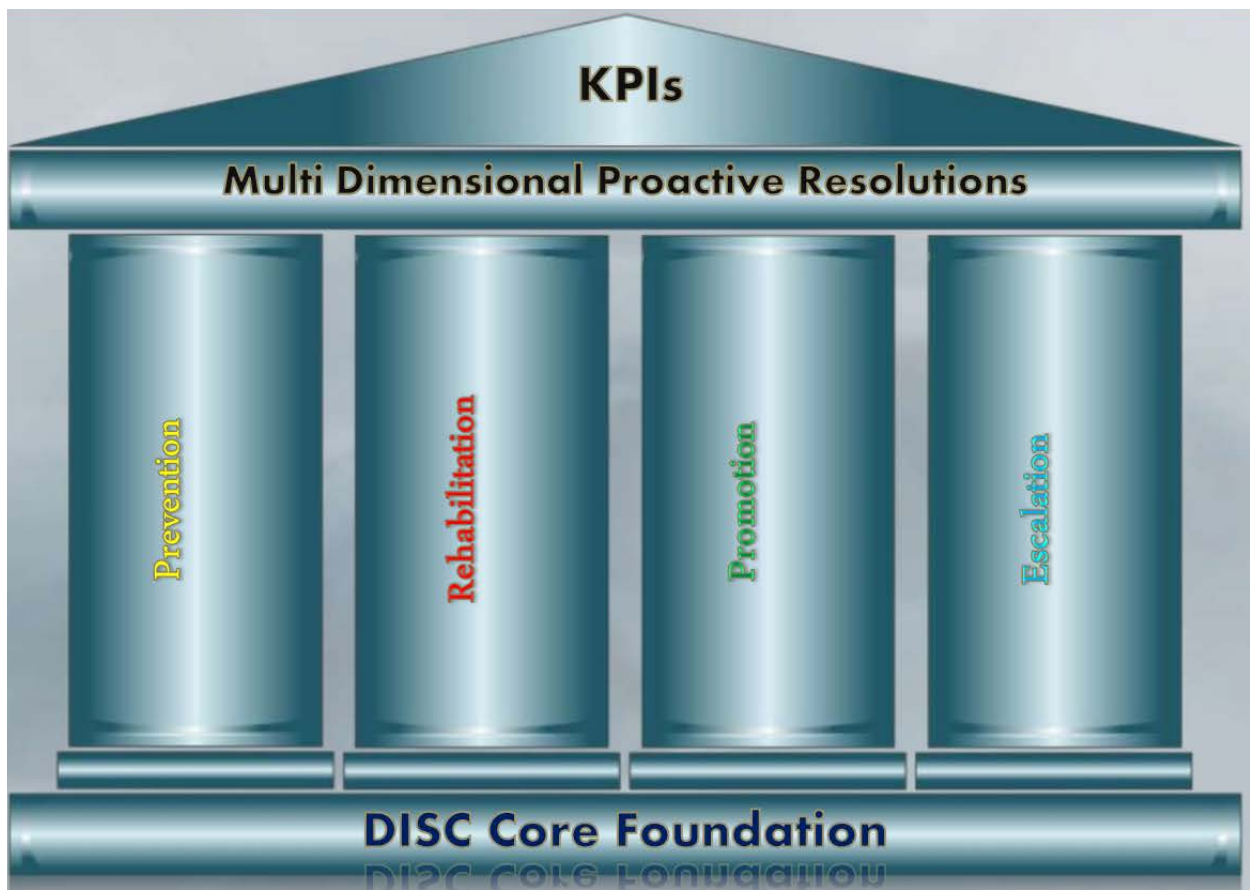

## INHOPE

### INHOPE is the International Association of Internet Hotlines.

It is an umbrella organization coordinating a network of Internet Hotlines all over the world, supporting them in responding to reports of illegal content to make the Internet a safer environment. INHOPE Members operate a public Hotline to receive complaints about apparent illegal content, they then assess the content in accordance with their national laws and if they consider it to be illegal they trace the material to a hosting country. If the content is illegal in the hosting

Country then the national Hotline takes steps to have the material 'taken down' in consultation with their law enforcement partners. As the definition of illegal content varies from country to country the landscape is quite complicated as to what practical measures can be taken. But in the case of child sexual abuse material there is a global consensus on tackling the problem and so all INHOPE Members have a common purpose which is to remove child sexual abuse websites from the Internet as soon as possible.

### INHOPE's Mission

**To support and enhance the performance of Internet Hotlines around the World; ensuring swift action is taken in responding to reports of illegal content making the internet a safer place. To achieve this mission, INHOPE has five specific objectives:**

→**To establish** policies and best practice standards for hotlines and encourage exchange of Expertise among members through fostering good working relationships and trust.

→**To ensure** rapid and effective response to illegal content reports around the world by Developing consistent, effective and secure mechanisms for exchanging reports between Hotlines internationally and ensuring a coordinated approach is taken.

→**To expand** the network of INHOPE Hotlines around the world by identifying and Supporting new Hotlines to become members by providing consultation and training to Meet best practice standards.

→**To promote** a better understanding of the work of hotlines to policymakers at an International level, including government, law enforcement and other related bodies, with The aim of achieving better co-operation internationally.

→**To raise awareness** of INHOPE and member hotlines with key stakeholders as well as The general public as a "one stop shop" for global reports of illegal content from around The world especially Child Sexual Abuse Material.

## Case Studies

### Case 1

Information supplied to the Australian Hotline by the UK Hotline led to the arrest of an Australian male.

He was charged with one count of using a carriage service to access Child pornography material, one count of distributing child exploitation material, two counts of making child exploitation material and five counts of possessing child exploitation material.

### Case 2

One of our Members received an anonymous report concerning child sexual abuse websites hosted in Germany.

Information was exchanged between two Hotlines. An Analyst was checking the relevant website and witnessed an announcement of new images and videos. This information was passed to law enforcement officers in two different countries. As a consequence an offender was identified and arrested and later was sentenced To seven years in prison.

### Case 3

A US Analyst viewed sexually abusive images and videos of an unidentified female child.

An adult male was depicted in the videos, in which only the side of his face was seen. Following further work it was established that the material was produced in a specific area of the UK.

Open source searches on the internet located images of the suspect which appeared consistent with the sexually abusive images. Police Officers also identified the child Victim. The offender concerned was the father of the victim. The suspect was sentenced to 15 years for sexual assault and distribution of child sexual abuse material.

### Case 4

Operation Carole, coordinated in Austria but started in Luxembourg with an investigations stemming from an anonymous report to the local Hotline. This operation led to 670 suspects worldwide being identified, followed by 456 arrests in many different countries.
